GATEWAY / LUNCH SPOTTERS

Terms and Conditions

- 1. These terms and conditions apply to entrants to the 'LUNCH SPOTTERS' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. The "Promoter" is Dexus Property Services Pty Limited (ABN 66 080 918 252). The address is Gateway, 1 Macquarie Place, Sydney, NSW 2000.
- 3. This Promotion will be conducted at Gateway, 1 Macquarie Place, Sydney. Phone 02 9256 6962 ("Centre").

ELIGIBILITY

- 4. This Promotion is only open to residents of NSW aged 18 years or over, who are able to attend the Centre between Monday 20 Friday 24 October 2025 and Monday 27 Friday 31 October 2025.
- 5. The following individuals are ineligible to enter the Promotion:

PROMOTION PERIOD

PRIZE DETERMINATION

CLAIM INSTRUCTIONS

 - b. upon successful validation (allow up to two business days), you will receive a SMS with instructions on how to claim your \$20.00 Lunch Spotters Pays-Enabled Digital Prepaid Gift Card (e-Gift Card);

10. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting a claim, including having the requisite photograph capability.

WINNER NOTIFICATION

- 11. The provisional winners will be instantly notified at the time of receiving a Winning Card. A provisional winner will only be deemed a winner upon providing required details and successful validation.
- 12. E-Gift cards can be accessed through the 'Winning Cards' unique QR code. Winners have up to two months to access and activate e-Gift card before prize is forfeited.

PRIZE CONDITIONS

- 13. Total prize pool of 250 \$20.00 Lunch Spotter e-Gift Cards, valued at a total of \$5,000.00 available during the randomised "spotter" time frame.
- 14. Any ancillary costs associated with redeeming the Lunch Spotter Pays-Enabled Digital Prepaid Gift Card ("e-Gift Card") are not included. The e-Gift Card must be activated within 2 months of issue and is valid for 12 months after activation. At expiry of the e-Gift Card any unused balance will be forfeited. Eligible Customers will not receive notice prior to expiry. - 15. To activate your e-Gift Card:
 - a. Click on the link in the text message to 'Redeem' your Lunch Spotters e-Gift Card. You have 2 months from the issuance date to activate the e-Gift Card.
 - b. You must have an Australian mobile number to activate.
 - c. You may need to enter your mobile number and the activation code that was provided in the SMS.
 - d. When your Lunch Spotters e-Gift Card is displayed, click "Add card to wallet" and follow the prompts to add your e-Gift Card to your phone's mobile wallet (e.g. Apple Pay, Google Pay or Samsung Pay).
 - e. Use the card in the mobile wallet for purchasing goods and services in the participating retailers and locations.
 - f. Once activated you have 12 months to use your e-Gift Card. You can check the balance and the expiry date of your card by returning to the link in the SMS and following the steps. Should you have multiple cards, you can view and manage all cards by downloading the Vault Payments App.
- 16. The e-Gift Card is only redeemable at participating retailers and locations (see Annexure 1).

UNCLAIMED PRIZES

17. There will be no unclaimed prizes as prizes will be automatically awarded to successful claimant, via a unique QR code associated with their prize. It is a claimant's responsibility to ensure that they submit their claim and enter their mobile number correctly. If they fail to submit a successful claim and/or enter their details correctly, the gift will be forfeited.

18. Upon successful validation of details, winners have up to two months from the date issued to access and activate e-Gift card before prize is forfeited.

GENERAL

The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
 - a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the prize value to that stated in these Terms and Conditions;

 - f. use of the prize,

PRIVACY
